## Sub: <u>Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015</u>

This is in continuation to our letters dated 6th September, 2023 and 30th November, 2023 wherein the Company had informed that the Hon'ble High Court at Calcutta vide its Order dated 5th September, 2023 has restrained the Company by an Order of temporary injunction from publishing the voting result or acting in terms of the voting result pertaining to Resolution no. 8 of the Addendum dated 14th August, 2023 to the Notice of 103rd Annual General Meeting (AGM) of the Company relating to the appointment of Mr. Sudeep Roy, for the office of Director proposed by a Member viz. The Produce & Trading Co. Pvt. Ltd. under Section 160 of the Companies Act, 2013 till 30th November, 2023 which was further extended till 22nd December, 2023 or until further orders, whichever is earlier.

In this context, we hereby inform the Stock Exchanges that the Hon'ble High Court at Calcutta vide Interim Order has further extended the temporary injunction restraining the Company from publishing the voting result or acting in terms of the voting result pertaining to the aforesaid matter till 31st January, 2024 or until further orders, whichever is earlier.

Copy of the Order of the Hon'ble High Court at Calcutta was received by the Company today i.e. 28th December, 2023 around 11.07 a.m. (IST).
