- 2 (Two) nos. of entities in promoter group namely East India Investment Co. Pvt. Ltd and The Punjab Produce & Trading Co. P.Ltd hold shares jointly with other shareholders under 9 (nine) different folios. In view of the above, though the number of shareholders based on PAN are 26 nos. but considering the above joint holding the number folios works out to 35.
  - Difference of shares in column No. (IX) [ Voting Rights] is due to 74851 Shares held under Unclaimed Share Suspense A/c.
  - 6520 shares are held in physical form which includes shares held by the Directors jointly with the promoters as qualification shares, shares held by the Administrators pendente lite over the Estate of Smt. Priyamvada Devi Birla, deceased as per the directive of the High Court, amongst others. Only 0.01% of the promoters' shareholding is in physical form, which is miniscule looking at the total size of the promoters' shareholding.
