Notes :

- There were no exceptional/extraordinary items during the quarter ended 30th September 2014.
- The Hon'ble Supreme Court, vide its decision dated 24th September, 2014, held allocation of various coal blocks as arbitrary and illegal and hence liable to be cancelled. Subsequently, the Government promulgated The Coal Mines (Special Provisions) Ordinance,2014, which intends to take appropriate action to deal with the situation arising pursuant to the Hon'ble Supreme Court's decision. In respect of Bikram Coal Block in the State of Madhya Pradesh allotted to the Company, the management is submitting its claim for compensation to the government for the investments made on the block. Consequential adjustments, if any, will be made in subsequent quarters on settlement of the claim.
- In respect of Mining matter of Chanderia, the Hon'ble Supreme Court has heard the matter on 13th October 2014 after getting the report from Central Building Research Instiute (CBRI) and has fixed the next hearing date on 17th November 2014.
- Effective April 1, 2014, the Company has charged depreciation based on the remaining useful life of the assets as per the requirement of Schedule II of the Companies Act, 2013. Due to above, depreciation charged for the quarter ended September 30, 2014, is higher by ₹ 536 lacs.
- Other expenses include Foreign Exchange Loss ₹ 197 lacs (Gain ₹ 1373 lacs) and Inter-unit freight on clinker transfer ₹ 4218 lacs (₹ 2614 lacs) during the quarter July-Sept.2014.
- Figures for previous periods have been regrouped/rearranged, wherever necessary.
- Ratios have been computed as follows:
 - Debt Service Coverage Ratio = (Profit before Interest & Tax)/(Interest Expenses+ Long Term Loan Repayments)
 - Interest Service Coverage Ratio = Profit before Interest & Tax/Interest Expenses
- The above results were reviewed by the Audit Committee on 4th November, 2014 and taken on record by the Board of Directors of the Company at its meeting held on 5th November, 2014.The above results have been reviewed by the Statutory Auditors of the Company.
