**Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015- Update on acquisition by RCCPL Private Limited, Wholly Owned Material Subsidiary**

This is in furtherance to our intimation dated 31st August, 2024 and 30th October, 2024, informing that RCCPL Private Limited ("**RCCPL**") wholly owned material subsidiary of the Company has entered into a Share Purchase Agreement ("**SPA**") and Power Purchase Agreement ("**PPA**") on 30th August, 2024 for acquisition of 3.12% equity shares of Continuum MP Windfarm Development Private Limited consisting of 1,39,15,200 equity shares aggregating to ₹13,91,52,000/- (Rupees Thirteen Crore Ninety-One Lakhs Fifty-Two thousand only) to source wind-solar power as a captive consumer for a capacity of upto 12 MW from a project located in Jaora in the State of Madhya Pradesh and also informing the extension of Long Stop Date, as mutually agreed between the parties to 31st January, 2025.

In this connection, we would like to inform you that the aforesaid acquisition of the shares in Continuum MP Windfarm Development Private Limited and all the customary formalities relating to the said acquisition have been completed. RCCPL now holds 3.12% equity shares in Continuum MP Windfarm Development Private Limited.

The Company has received the intimation about credit of shares in the demat account of RCCPL today i.e. 12th November, 2024 at around 10.36 a.m.

The details as required under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July, 2023 were already disclosed by the Company in the intimation dated 31st August, 2024.
