### **GENERAL REVIEW:**

A Memorandum of Understanding was signed between Birla Corporation Limited, the Holding Company and Assam Minerals Development Corporation (AMDC), a Government of Assam undertaking, to set up one-million ton greenfield cement plant at Umrangsu in the North Cachar Hills district, Assam by converting the Company into a Joint Venture Company with an investment of ₹ 450 crores. The activities to set up the plant will be initiated after the JV agreement is signed with the AMDC for which necessary follow-up measures are being taken.

Shri P.K. Chand resigned during the year. The Board places on record its appreciation of the services rendered by him during his tenure as Director of the Company.

Shri B.R. Nahar retires by rotation at the forthcoming Annual General Meeting and offers himself for re-appointment.

Shri A. Saraogi and Shri M.K. Mehta, appointed as additional Directors of the Company during the year, holds office up to the date of ensuing Annual General Meeting and being eligible, are proposed to be appointed as Directors liable to retire by rotation.

### **AUDITORS:**

Messrs. Alps and Co., Chartered Accountants, retire as Auditors of the Company and being eligible, offer themselves for re-appointment.

INDEPENDENT AUDITOR'S REPORT

To The Members of **BIRLA CEMENT (ASSAM) LIMITED**,

Report on the Financial Statements

We have audited the accompanying financial statements of **BIRLA CEMENT (ASSAM) LIMITED**, which comprise the Balance Sheet as at 31st March, 2013 and the Statement of Profit & Loss Account and Cash Flow Statement for the year ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flows of the Company in accordance with the Accounting Standards referred to in sub-section (3C) of section 211 of the Companies Act, 1956 ("the Act"). This responsibility includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.







#### **1. Significant Accounting Policies**

##### **1.1 Basis of Accounting**

The financial statements are prepared under the historical cost convention, except stated otherwise, on an accrual basis and in accordance with the generally accepted accounting principles in India, the applicable mandatory Accounting Standards as notified by the Companies (Accounting Standard) Rules, 2006 (as amended) and the relevant provisions of the Companies Act, 1956.

The financial statements had been prepared and presented as per the requirement of Revised Schedule VI as notified under Companies Act 1956.

##### **1.2 Use of Estimates**

The preparation of financial statements require judgements, estimates and assumptions to be made that affect the reported amount of assets and liabilities including contingent liabilities on the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Difference between actual results and estimates are recognized in the period in which the results are known/materialised.

All Income and Expenditure are accounted for on accrual basis.

##### **1.4 Taxation**

Provision for Current Income Tax is made in accordance with the Income Tax Act, 1961. The Deferred Tax charge or credit is recognised using substantively enacted tax rates subject to consideration of prudence on timing differences between book and tax profits.
